

2015 PRINCETON SQUARE Pool Information

OPERATIONAL HOURS

The Princeton Square pools will open on **Friday, May 9, 2015**. Lifeguards will not be on fulltime until May 22 and will only be on during the weekends prior to that date. The hours are daily from **8:00am until 10:00pm**.

By being in the secured amenities area outside of these hours, you agree to accept all risks and acknowledge that the Association is not responsible for your safety.

Anyone using the pool facility outside of operational hours will be considered trespassing and the police will be notified. Trespassers are subject to the authority of the sheriff's office regarding trespassing laws and regulations. Violators of any rule are subject to Board review and potential loss of amenities access.

ELIGIBILITY

As of May 9, 2015, key cards will be **deactivated** for members who are **not** current on association fees and/or an approved payment plan. This includes any tenant whose landlord is in arrears. If your dues are not paid, please contact Heidi Lindquist (678.710.6089; hlindquist@accessmgt.com) to arrange payment. For those on a payment plan, missing a payment will result in deactivating your key card until the balance is paid. Every Member in good standing is welcome to bring up to 5 guests at one time. The Member must accompany the guests at all times. More than 5 guests is considered a party and subject to pool committee approval. Please email board@princetonsquarehoa.org for approval. **Unescorted guests may be asked to leave the pool.**

LIFEGUARDS & RULES

Lifeguards will be on duty between the hours of **11:00am and 6:00pm**. They are responsible for enforcing the Pool Rules and have the authority to eject a rule abuser from the pool area.

Members -- familiarize your children (and guests) with the pool rules listed below. You (or your authorized adult) will be held responsible for your child's behavior whether you are present at the pool or not.

1. Children under age **12** are **not** permitted unless accompanied by a responsible person age 18 or older.
2. Glass containers are **not** permitted inside the pool area.
3. Children who are **not** toilet trained will be allowed in the pool only when wearing a bathing suit and rubber pants over a diaper or swimming diapers. Fecal matter in the pool results in closing the pool for cleaning and disinfection at a cost of **\$125** per incident. This cost will be assessed to the Lot responsible for that child. If you see anyone abusing this rule, speak up. It is for everyone's safety.
4. Pets are **not** permitted in the pool area.
5. Bicycles, skateboards or other vehicles are **not** allowed in the pool area.
6. Running, pushing, wrestling or undue disturbance is **not** permitted in the pool area.
7. Loud music is **not** permitted. If you are asked to lower the music volume, please comply.

8. Every Member in good standing is welcome to bring up to 5 guests at one time. The Member must accompany the guests at all times. More than 5 guests is considered a party and subject to pool committee approval. Please email pool@princetonsquarehoa.com for approval.
9. Please clean up after yourselves (e.g., food, drink, litter) prior to leaving the premises.
